**Extended Stray Round-4 (Offline) for Nursing Courses**

It is for the information of all eligible candidates that the Physical Allocation of Seats, Verification of Original Documents and deposition of provisional tuition fee on spot in **Extended-Stray Round-4 (Offline)** for admission to Nursing (**Irregular Batch**) Courses in all Govt./Private Nursing Colleges for the academic session 2023-24 will be held in **Committee Room, Director Office, PGIMS, Rohtak** as per schedule given below:

**Note:-**

1. The candidates must bring all relevant original documents at the time of counselling for Extended Stray Round-4 (Offline), failing which their candidature shall not be considered.
2. Personal appearance must be ensured by the candidate failing which their candidature shall not be considered.
3. The candidates who have been found eligible after successful document verification in Extended Stray Round-3 (Offline) of counselling but did not join to the opted college, shall not be eligible to participate in the Extended Stray round-4 (Offline).
4. The candidates who have joined on the allotted seats upto Extended Stray Round-3 of counselling shall not be eligible to participate in Extended Stray Round-4 (Offline) even after resignation/ vacating the joined/allotted seat.
5. Shifting from one college to another college and one course to another course is not allowed in Extended Stray round-4 (Offline) of counselling.
6. Other terms and conditions remains the same as in **Government of Haryana Notification dated 01.06.2023** and public notices issued from time to time.
7. **Candidates after successful physical verification of documents will be considered as “joined” to allotted colleges.**
8. **The candidate will have to deposit the provisional tuition fee at the time of physical verification of documents in the shape of Demand Draft drawn in favour of “Counselling and Admission on A/c for DMER” payable at Sampla (Rohtak), Bank ICICI Bank Ltd. Candidate who fails to deposit provisional tuition fee even on spot will not be considered. Candidates are advised to get prepared multiple Demand Drafts.**
