"The posts of tenure Senior Resident/Demonstrator/Tutor are not faculty position."

Abbreviations: UR- Unreserved, SC – Schedule Caste, BC- Backward Cast, EWS- Economical Weaker Section, ESM – Ex Servicemen, PwD – Person with Disability.

Application Fees:-

A crossed Demand Draft (In Original) must be accompanied with application form worth Rs. 1000/- for General Category and Rs. 250/- for Reserved Categories (for Haryana Domicile only) in favour of the Principal, PGIDS, Rohtak. 50% concession in the above fees is granted to the women candidates (both general and reserved category) as per Govt. Instruction. PH & ESM candidates are exempted from the application fee.

QUALIFICATION & EXPERIENCE FOR SENIOR RESIDENTS (DENTAL)

1. A basic University qualification included in the Scheduled to the Dentist Act, 1948 (16 of 1948).
2. MDS in the subject concerned.
3. Must be registered under Dental Council of India.

QUALIFICATION FOR SENIOR RESIDENTS (MEDICAL)

1. MBBS from Institute/University recognized by the MCI
2. MD/MS/DNB in the subject concerned.
3. Must be registered under the State/Central Medical Registration Act.

QUALIFICATION OF TUTORS (MEDICAL)

In the subject of Anatomy, Biochemistry, Physiology, Pharmacology and Microbiology candidates possessing M. Sc. (Medical) qualification in the subject concerned are eligible to apply.

Pay Scale of Senior Resident (Dental/Medical)

Rs. 67,700 + 13,540 NPA + DA (admissible as allowed by the Govt. from time to time) to MDS/MD/MS/DNB degree holder

Pay Scale of Tutor (Medical)

Age:-

The age for the post of Senior Resident and Tutors below 45 years of age as on the closing date of Advertisement.

The Benefit of relaxation in upper age in respect of candidates to SC/ST, BC, ESM etc. will be as per Haryana Govt. Instructions issued from time to time and is restricted to Haryana Domicile only.

General Terms & Conditions:-

1. Number of posts is liable to increase or decrease either way, including complete withdrawal without assigning any reason.
2. No separate interview letter will be sent and no TA/DA will be paid for attending the scrutiny/interview. All information relating to this advertisement may be seen on University Website www.uhsr.ac.in
3. The following documents in original are to be produced at the time of scrutiny/interview:-
 - a. 10th class Certificate as proof of Date of Birth.
 - b. Certificate for proof of reservation category, if applicable.
 - c. BDS/MBBS, MDS/MD/MS/DNB, Post Doctoral Degrees.
 - d. Attempt certificate during various Degree programme.
 - e. DCI/MCI (now NMC)/State Dental registration Certificate/State Medical registration Certificate.
 - f. Certificate of additional qualifications where applicable.
 - g. Experience Certificate.
 - h. Research publication along with proof of indexing and status of the journal in which the research article has been published.
 - i. Certificate of presentation of the research article at a conference.
 - j. Sports certificate for prize or position in an international/national/inter university sports or athletic meet.
 - k. College Colour Certificate for sports.
 - l. Any other certificate, if any.

The above mentioned documents {(Sr. No. 3 (c) to 3(l)} are required to calculate the pre-merit as per selection criteria attached at **Annexure- 'B'**.

4. Separate application form may be submitted for separate post.
5. Where there is a shortage of Senior Residents /tutors and eligible candidates are not available, the candidates, who have completed one tenure of three year, can be considered for Second tenure.
6. Those students who are doing DM/M. Ch/Ph.D course, on selection as Senior Resident /Tutor will have to discontinue their DM/M. Ch./Ph.D Course before joining the post.
7. The applicants who are already in Govt./Semi Govt./Corporation or Autonomous Body Service should sent application through their respective Head of the Institute or bring fresh 'No Objection Certificate' at the time of interview failing which the applicant will not be allowed/considered for interview, NOC may not be older than three months.
8. Mere submission of the application and call for interview does not mean that the aspirant is eligible for the post applied for. The eligible shall be verified before the interview as per the qualifications, experience and other terms and conditions given in the advertisement.
9. Four percent of the posts shall be reserved for persons with disability (PwD Category). A person who wants to avail of the benefit of reservation would have to submit a Disability



Certificate issued by a Competent Authority on prescribed format as notified by the Govt. from time to time.

10. In case any applicant belonging to Scheduled Castes or Backward Classes or any reserved category applies against General Category post, he/she must fulfil the conditions of the eligibility regarding age, qualifications and experience and application fee etc. as are meant for General Category candidates.
11. In case any discrepancy is detected in the document submitted by the applicant or in the process of selection, at any stage even after the issue of appointment order, the competent authority reserves the right to modify/withdraw/cancel any communication made to the applicants.
12. The decision of the appointing authority in all matters relating to acceptance or rejection of application, eligibility/ suitability of the applicants, mode and criteria for selection etc. shall be final and binding on the applicants.
13. All disputes pertaining to the recruitments of various posts shall fall within the jurisdiction of Rohtak only.
14. The prescribed qualification, experience and age etc. shall be reckoned as on the closing date of advertisement.
15. The degrees of undergraduate/postgraduate not recognized by the NMC/DCI (erstwhile MCI)/UGC shall render the applicant ineligible for the said post.
16. Any change in the category mentioned in the application form after the closing date/time of submission of application form will not be allowed.
