- The Form of Bid should be completed in all respects duly signed and stamped by an authorized and 18. empowered representatives of the Bidder. If the Bidder comprises a partnership Cooperative Labour and Construction Societies or agency consisting of all Schedule Caste members or all women members, bid shall be signed by a duly authorized representative and relevant power of attorney shall be attached.
- The contract shall be valid initially for one year but to be reviewed after completion of one year period 19. and may be extended for another one year, subject to satisfactory services only.
- Any e-tender not accompanied by Bid Security shall be rejected. 20.

- If the successful bidder fails to furnish the performance security/bank guarantee or fails to execute the agreement, the authorities may terminate the contract. In such an eventuality, earnest money deposited shall stand forfeited.
- Pt. B.D Sharma UHS, Rohtak will award the contract to the successful evaluated bidder whose bid has been found to be responsive and who is eligible and qualified to perform the contract satisfactorily as 34. per the terms and conditions incorporated in the bidding document
- The authorities will communicate the successful bidder by email and Registered post that his bid has been accepted. This letter (hereinafter and in the condition of contract called the "Letter of Award") 35. shall prescribe the amount which Department will pay to the contractor in consideration of the execution of work/services by the contractor as prescribed in the contract.
  - The successful bidder will be required to execute an agreement in the form specified in Annexure –IV within a period of two weeks from the date of issue of Letter of Award but before the work is taken up for execution.
  - The successful bidder shall be required to furnish a Performance Security/Bank Guarantee within two weeks of receipt of 'Letter of Award' for an amount equal to 10% (Ten Percent) of the estimated total cost of the contract for one year, in the form of Bank Guarantee from a commercial bank in an acceptable form (Annexure -VI) in favor of the Registrar, Pt. B.D Sharma UHS, Rohtak. The Performance Security/Bank Guarantee shall remain valid up to clearance of all dues. In case the contract period is extended further, the validity of Performance Security shall also be extended by the contractor accordingly.
  - Failure of the successful bidder to comply with the requirements of above clauses shall constitute sufficient grounds for the annulment of the award and forfeiture of Bid Security.
- The personnel (if any) hired by the service provider for this service shall for the purposes of this contract be the employees of the Cooperative Labour and Construction Societies or agencies 36. consisting of all Schedule Caste members or all women members who will be responsible to provide all fringe benefits viz. PF, ESI facilities to them. The personnel (if any) so deployed by the Cooperative Labour and Construction Societies or Agency consisting of all Schedule Caste members or all women members will not have any legal claim under provisions of Industrial Dispute Act and Contract Labour Act against Pt. B. D. Sharma UHS, Rohtak not being employees of Pt. B. D. Sharma UHS, Rohtak.
- 37.
- (a) In case the service provider fails to commence the work as stipulated in the agreement, the University Authorities reserve the right to impose and recover penalty as detailed below:-
  - 2% (two percent) of cost of order/agreement per week up to four weeks delays in commencement of work.
  - After four weeks delay, the authorities may cancel the agreement and get this job carried out preferably at the same rate as of L1, from L2/L3 and on if L2/L3 does not agree then (ii) through any Cooperative Labour and Construction Societies consisting of all Schedule Caste members and other Agency from the other bidder. The difference in cost, if any, will be recovered from the defaulting service provider as damages and he shall be black listed for a period of three years from participating in such types of e-tenders and his security deposit shall also be forfeited, if so warranted.
  - (b) The service provider shall comply with all the relevant laws and statutory requirements covered under various Labour Acts, Minimum Wages Acts, Contractual Labour (Regulation & Abolition Act 1970, EPF, ESI etc. with regard to the personnel (if any) engaged by him for lifting and transportation of General Waste. It will be the responsibility of the service provider to provide certified details of manpower deployed by him on monthly basis in the 'UHS' and to the Labour Department in the appropriate format by 3<sup>rd</sup> of the succeeding month. The default shall attract a penalty at the rate of 2% (two percent) per month on the monthly wages bill of the concerned month.
  - (c) If the contractor is found that he is not providing the satisfactory services as per contract, the contractor may be penalized the amount of Rs.2000/- at first occasion, Rs.5000/- at second occasion and Rs.10000/- at third occasion. Even then, if the services are not improved by the contractor, then the authority will be at liberty to terminate the contract after issuing show cause notice and till the maturity of subsequent contract the continuation will be got done at the risk and cost of the contractor recoverable from his security /bank guarantee.
  - (d) The competent authority for imposing the penalty shall be the Vice-Chancellor, Registrar, Director and Medical Superintendent.
  - The persons if so deployed shall be under the overall control and supervision of the contractor and 38. the contractor shall be liable for payment of their wages etc. and all other dues which the contractor is liable to pay under the various Labour Regulations and other statutory provisions (i.e. EPF/ESI).

- 39. The contractor shall ensure compliance of General Waste Management Rules, 2016 and/ or any other statutory rules framed by the Government from time to time regarding General Waste.
- 40. The institute shall not be liable to the payment of any compensation to any of the staff so deployed by the contractor on duty for any accident suffered while lifting & transportation of the General waste.
- 41. The Cooperative Labour and Construction Societies or Agency consisting of all Schedule Caste members or all women members shall submit the bill in the MG Branch, Director Office, PGIMS, Rohtak on reimbursement basis on I<sup>st</sup> of every succeeding month for making payment on the reimbursement basis. The payment will be released after the deduction of penalty, if any, imposed by the competent authority as per contract agreement. The Income Tax or any other statutory levy/tax as applicable will be payable by service provider and shall be deducted at source as per law. The Cooperative Labour and Construction Societies or Agency consisting of all Schedule Caste members or all women members shall also submit an affidavit/ undertaking along with the bill that the Cooperative Labour and Construction Societies or Agency consisting of all Schedule Caste members or all women members has complied with all the applicable laws and have ensured statutory compliances to all its workers (if any) hired for providing the service under this contract.
  - 42. Any liabilities arising out of any litigation (including those in consumer courts) due to any act of service provider's personnel shall be directly borne by the service provider including all compensation/ damage/ expenses/ fines/ deaths of personnel while on duty. The concerned service provider personnel shall attend the court as and when required. Any liability arising due to penalty/ damages etc. from any statutory authorities like EPF/ ESI authorities etc. shall be borne only by the vendor and in no case the same shall pass on to the institute on any pretext by the vendor.
  - 43. The Pt. B.D Sharma UHS Rohtak does not recognize any master servant relationship with any of the workers of the service provider. The contract worker (if any) hired by the Cooperative Labour and Construction Societies or Agency consisting of all Schedule Caste members or all women members is the employee of the service provider and can in no way claim any right for regularization of service with the Pt. B. D. Sharma, UHS, Rohtak.
  - 44. The service provider shall ensure full compliance with tax laws of India with regard to this contract and shall be solely responsible for the same. The Cooperative Labour and Construction Societies consisting of all Schedule Caste members or Agency shall submit copies of acknowledgements as a proof of filing of returns every year and shall keep the Employer fully indemnified against liability of tax, interest, penalty etc. of the Cooperative Labour and Construction Societies or Agency consisting of all Schedule Caste members or all women members in respect thereof, which may arise.
  - 45. Force Majeure: If at any time during the period of the contract, either party is subject to force majeure, which can be termed as natural disasters or, acts of God etc. which may prevent either party to discharge its obligation, the affected party shall promptly notify the other party about the happening of such an event. Neither party shall by reason of such event be entitled to terminate the contract in respect of such performance of their obligations. The obligations under the contract shall be resumed as soon as practicable after the event has come to an end or ceased to exist. If the performance of any obligation under the contract is prevented or delayed by reason of the event beyond a period mutually agreed to if any or 21 days, whichever is more, either party may at its option terminate the contract.
  - 46. Dispute Resolution: -
    - (a) Any dispute and or difference arising out of or relating to this contract will be resolved through joint discussion of the authorized representatives of the concerned parties. However, if the disputes are not resolved by joint discussions, then the matter will be referred for adjudication to a sole Arbitrator appointed by the Vice-Chancellor, Pt. B. D. Sharma, University of Health Sciences, Rohtak.
    - (b) The award of the sole Arbitrator shall be final and binding on all the parties. The arbitration proceeding's shall be governed by Indian Arbitration and Conciliation Act, 1996 as amended from time to time.
    - (c) The cost of Arbitration shall be borne by the defaulter. During the pendency of the arbitration proceeding and currency of contract, neither party shall be entitled to suspend the work/service to which the dispute relates on account of the arbitration and payment to the Cooperative Labour and Construction Societies or Agency consisting of all Schedule Caste members or all women members shall continue to be made in terms of the contract. Arbitration proceedings will be held at Rohtak.
  - 47. <u>Jurisdiction of Court</u>: The courts at Rohtak shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.
