Sub: **Addition in Clause – 2 (B) and 29(Note-VIII A) for pharmacy Courses only of the Ordinance regarding condition of Affiliation of Colleges & Institutions to the privileges of the University and the withdrawal of such privileges.**


The Executive Council of the University vide Resolution No.42.13 in its 42nd meeting held on 21/5/2021 has considered the recommendations of the Academic Council vide Resolution No. 17.20 of its meeting held on 22.9.2020 and approved the following:-

Existing	Proposed
2. An application for grant of affiliation /consent of affiliation shall be made by the officer authorized by the Govt. of Haryana in the case of a Govt. college/institution and by the Chairperson of the Managing Body/Trust/Society or any other authority appointed for the purpose by the Management of the college in the case of non-govt. college along with the prescribed fees.	No Change
A)Last date for submission of application / proposal for affiliation/consent of affiliation alongwith prescribed processing fee for new College/Institute/increase intake/additional course(s)/specialization/subject(s) etc, without late/extra fee shall be 31 <sup>st</sup> Oct. of the preceding year to which it is proposed to start.	No change
B)Proposal/application for affiliation/consent of affiliation shall be entertained upto 31 <sup>st</sup> December of the preceding year on payment of 50% extra charges and upto 31 <sup>st</sup> March of the year concerned on payment of 100% extra charges.	No change
	<b>B:</b> <u>Only for Pharmacy courses.</u>  Last date for submission of application / proposal for affiliation/consent of affiliation along with prescribed processing fee for new College / Institute /increase intake /additional course(s)/specialization/subject(s) etc, without late/extra fee shall be 31 <sup>st</sup> Oct. of the preceding year to which it is proposed to start.  Proposal/ application for affiliation/consent of affiliation shall be entertained upto 30th November of the preceding year on payment of 50% extra charges and upto 31 <sup>st</sup> December of the year concerned on payment of 100% extra charges.

Clause 29- Note (viii A)- B.Pharmacy colleges/Institutions shall deposit the annual continuation fee upto 31<sup>st</sup> December failing which penalty of Rs.1000/- per course per day shall be charged.

The above decision of Executive Council has come into force w.e.f. 17/9/2019 when circular was issued .


