This is for information of all concerned that the MOP-UP Round of counseling for admission to M. Pharmacy Courses for the Academic Session 2023-24 in Constituent / affiliated Pharmacy Institutions of Pt. B.D. Sharma University of Health Sciences, Rohtak will be held on 15.09.2023 in the Committee Room, Director's Office, PGIMS, Rohtak. All the eligible candidates must bring their original documents/certificates for verification before the Admission Committee. The reporting time at the counselling venue is 09.00 AM.

#### Note:-

- 1. All the candidates must regularly visit the University website <a href="www.uhsr.ac.in">www.uhsr.ac.in</a> regularly for any updates.
- 2. No separate intimation shall be communicated to the candidates for counselling.
- 3. All concerned candidates should positively report at the venue at 09.00 AM along with relevant original documents/certificates. (As per Annexure-A).
- 4. The candidates are required to bring demand draft of Rs.20,000/- on account of provisional tuition fee in favor of "Controller of Finance, UHS, Rohtak". This payment can also be deposited through *Debit Card / Credit Card on the spot*. The remaining fee must be deposited in the allotted institute. The candidates who have not paid the tuition fee will not be considered for admission.
- 5. Shifting from one college to another & one specialty to another Specialty is not allowed in MOP-UP round of counselling.
- 6. Conversion of seats PWBD Category to ESM/FF Category will be done as per Govt. of Haryana Policy issued from time to time after exhaustion of merit list. After exhaustion of merit list of candidates who have applied under various reserved categories, vacant seats (if any) shall be reverted to their original category of seats and if still there is a vacancy, the same shall be converted to unreserved category / management seats and filled up in the MOP-UP round- itself for both Government and Private Pharmacy Colleges.

Sharma University of Health Sciences, Rohtak. The following list of documents must be brought for document verification before Admission Committee:-

- 1. Matriculation Certificate/High School/ICSE/Class X/Class XII or an equivalent certificate as proof of date of birth.
- 2. Three copies of the recent self attested passport size photographs.
- 3. Character certificate from the Head of last attended institution or a First Class Executive Magistrate.
- 4. Residential certificate issued by competent authority of the State Government of Haryana (if applicable or a bonafide resident certificate issued by the competent authority of the State Government (if applicable).
- 5. Caste Certificate issued by competent authority of the Haryana State Government (if applicable).
- 6. Creamy / Non-Creamy certificate for BC-A / BC-B category candidates as per the Govt. of Haryana notification dated 17.11.2021. This certificate should be for the year 2023-2024 and issued on/after 01.04.2023 (if applicable).
- Proof of identification such as Aadhar Card/PAN Card/Driving License/Passport/Voter ID/Ration Card/Parivar Pehcahan Patra.
- 8. For candidates with CGPA grades, a certificate must be provided that includes the conversion factor from respective University, without this his/her candidature will not be considered.
