All candidates should ensure to upload all requisite documents on the Admission Web Portal and complete the registration process as per schedule.

- a) The candidates who have already registered themselves for the first round and wish to participate in the second round, shall not be required to register again.
- b) The candidates who have been allotted seats in the first round of counseling shall have to give their willingness/option to upgrade themselves in the second round of counseling online otherwise they shall not be considered eligible for the second round of counseling.
- c) The Candidate who has joined on the allotted seat in the first round shall retain the allotted seat and this shall be changed only if he/she gets an updated and opted seat during second round. However, the candidates who wish to participate in the 2nd round of online counseling will have to submit their preferences/choices afresh. Candidates, who have been allotted, seat in first round should give the fresh choices in order of preferences carefully for the seats in which they wish to upgrade themselves.
- d) In case the candidate opts for upgradation in Round-II counselling but is not upgraded then he/she cannot participate in Mop-up Round/further round of counselling (if any).
- e) Any candidate who had joined in Round-I but does not participate in Round-2 counselling or do not resign from the Round-1 allotted seats by 15.09.2023 (05:00 PM), will also be not allowed to participate in Mopup/further round of counselling (if any).
- f) The candidates who have joined the seat allotted to them upto Round-II of counselling, shall not be eligible to participate in Mop-up Round/further round of counselling (if any).

- If there is any change in the allotted course/institute in Round-II after editing of personal information (ifany) by any candidate, the course/institute allotted in Round-II will be final.
- The choices filled by the candidates for the first round of counseling shall be treated as null and void and the candidates will have to fill fresh choices to be eligible for participating in the second round of counseling.
