It is for the information of all the eligible candidates desirous of seeking admission to MD/MS/MDS courses in all Government/ Government Aided/ Private Unaided Medical/Dental Institutes including those under Private Universities - SGT University, Budhera, Gurugram, PDM University, Bahadurgarh,AI-Falah University Village Dhoj, Faridabad and Post MBBS DNB/Post MBBS Diploma/Post Diploma DNB courses in Civil Hospitals in the State of Haryana for the Academic Session 2023-24, the tentative schedule for **ROUND-3** of counseling is as under :-

### Note:-

- a) The candidates, who have already registered themselves for the Round-1 & Round-2 and wish to participate in the Round-3, shall not be required to register again.
- b) The candidates, who have been allotted seats in the Round-1 / Round-2 of counseling shall have to give their willingness/option to upgrade themselves in the Round-3 of counseling status online otherwise they shall not be considered eligible for the Round-3 of counseling.
- c) The Candidates, who have joined on the allotted seat in the Round-1/ Round-2 shall have a right to already allotted seat and this shall be changed only if, he/she gets an upgraded opted seat during Round-3. However, the candidates who wish to participate in the Round-3 of online counseling will have to submit their preferences/choices afresh. Candidates, who have been allotted, seat in Round-1/ Round-2 should give the fresh choices in order of preferences for the seats in which they wish to upgrade themselves.
- d) All candidates (already registered (irrespective of their admission status) and freshly registered candidates} who wish to participate in the Round-3 of counseling and want to opt for State Quota Seats in only Government/Government Aided/ Private Unaided Medical/Dental Colleges/hospitals shall be required to deposit security fee online an amount of Rs. 25,000/- (Rs. 12,500/- for SC/SCD/BCA/BCB/EWS/PWBD of Haryana State) and if the candidate wishes to also opt for State Quota Seats/Management Quota Seats in Private Medical/Dental Colleges including Private Universities the he/she shall have to deposit online an amount of Rs. 2.00 Lakh. This facility shall be available in the login ID of the candidates on admission webportal.

In case of failure of any registered candidate (whether freshly registered or the candidates who were allotted seats in the Round-1/ Round-2 and want to upgrade their seat in the Round 3) to deposit the requisite security amount, they will NOT be considered eligible to participate in the Round-3 of counseling.

- In case of candidate join on the allotted seat, this security amount shall be adjusted in the tuition fee of the first year of PG Course.
- If the candidates are allotted any seat as per their preference, but they do not join on the allotted seat, the security amount shall be forfeited. However, these candidates will be eligible to participate in the further/stray round after forfeiture of previous security amount and deposition of fresh security amount.
- The security amount of the candidates who are not allotted any seat during the Round 2/Round-3 shall be returned after the completion of the counseling process.
- The candidates, who join on the allotted seats in the Round-2 of counseling, will be eligible to participate for Round-3 of counseling.
- Any candidate who had joined in Round-1 but do not participate in Round-2 counseling or do not resign from the Round1 allotted seats, will also be allowed to participate in Round-3.
- The candidates who join the seat allotted to them during the All India Quota/Any State upto Round-3
  of counseling shall not be eligible in further / stray round of counseling. The candidates will have to
  give undertaking about the same.
- However, if a candidate do not want Round-2 seat, he may exit with forfeiture of security amount.
- In case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled during document verification or fails to produce the required documents at the time of document verification, the security amount fee shall be forfeited.
- Conversion of unutilized PWBD Category seats to ESM/FF Category will be done as per Govt. of Haryana Policy issued from time to time after exhaustion of merit list. After exhaustion of merit list of candidates who have applied under various reserved categories, vacant seats (if any) shall be reverted to their original category of seats and if still there is a vacancy, the same shall be converted to unreserved category/ management seats and filled up in the round-3 round itself in the Government and Private Medical Colleges/hospitals accordingly.

Note: -

- The choices filled by the candidates for the Round-1/ Round-2 of counseling shall be treated as null and void and the candidates will have to fill fresh choices for Round-3.
- The above instructions should be read in accordance with NEET PG information bulletin 2023 and Govt. of Haryana notifications dated 02.08.2023 and 09.08.2023 and public notices issued by DMER/MCC/Admission Committee time to time.
