For Admission in Pvt. Institutions as per annexure V(b) including those under Private Universities as per annexure V(c) -

For MDS Courses - 50% of Tuition Fee/ Course Fee as per Notification No.16/3/2018-6HB-IV dated 03.09.2021.  
- Remaining tuition fees will have to be deposited in the college concerned.

For the convenience of the candidates, the candidates are allowed to submit multiple demand drafts as per their convenience considering different fee in Govt./Private institutes the fee in all institutes has already been notified in the Govt. Notification No.16/3/2018-6HB-IV dated 03.09.2021. The candidates can also deposit the fee through RTGS/NEFT and Debit card/credit card on the spot.

Unfilled PWBD Category seats after giving opportunity to the category candidates will be converted to ESM/DFF will be filled up as per State Govt. Policy in Mop Up Round.

The unfilled seats reserved for category candidates (SC/BC etc.) in Govt./Pvt. Dental Institutions will be converted only after giving complete opportunity to the students of respective category in Mop Up Round.
