Counselling for admission to MD/MS/MDS Courses in all Government/ Government Aided/ Private Unaided Medical/ Dental Institutes including those under Private Universities - SGT University, Budhera, Gurugram, PDM University Bahadurgarh, Jhajjar in the State of Haryana for the Academic Session 2020-21.
