Second round of Counseling/ mop-up round for Admission to vacant/left over seats in MD/MS/PG Diploma and MDS Courses in Government/Government aided/ Private unaided Medical/Dental Institutes including those under Private/Deemed Universities in the State of Haryana for the Academic Session 2017-18

It is for the information of all eligible candidates that in view of the orders dated 25.05.2017 and 30.05.2017 passed by the Hon'ble Supreme Court of India in SLP(C) No. 15171-15173 of 2017 titled State of Haryana and another etc. Vs. Dr. Narender Soni & others etc. etc. and SLP(C) No. 15869 OF 2017 in LPA No. 762 of 2017 titled Dr. Ankit & others Vs. State of Haryana and others respectively, the counseling conducted on 7.5.2017 and 22.5.2017 & 23.5.2017 stands cancelled. The Hon'ble Supreme Court of India has permitted the State of Haryana to complete the process of admission to PG Courses by 10th June, 2017 vide its order dated 30.5.2017. The 1st round of counseling has already been conducted on 30/31.5.2017 and the 2nd round of counseling will be held as per the following schedule-

06.06.2017 10:00AM onwards for MD/MS and PG Diploma courses.
 07.06.2017 10:00AM onwards for MDS Courses

The counseling shall be held in the office of Director, PGIMS, Rohtak. All the eligible NEET qualified candidates desirous of seeking admission and who have registered themselves on the admission web portal/who have applied in Maharishi Markandeshwar University Mullana, Ambala in compliance with the interim orders dated 04.05.2017, passed by the Hon'ble Supreme Court of India in Writ Petition Civil No.244 of 2017 titled, 'Education Promotion Society of India & Ors vs. Union of India & Ors' are advised to be physically present as per above mentioned schedule at the venue of counseling with all original documents and prescribed fee.

Final number of seats available in each specialty under each category and in each Institute shall be displayed at the time of counseling. The candidates shall be allotted specialty and institute based on their merit and option to be exercised by them at the time of physical counseling.

The mop-up round for filling vacant seats left after 2nd round of the counseling shall be held on 9.05.2017, 10:00 AM onwards in the office of Director, PGIMS, Rohtak.

Candidates are advised to visit the website of Pandit Bhagwat Dayal Sharma University of Health Sciences, Rohtak - www.uhsr.ac.in and admission web portal www.uhspgadmission.in regularly for any update and merit list/vacancy position.

1. It is intimated that admission of all the candidates will be provisional and subject to the final outcome of decision pending in LPA no. 762 of 2017 titled Vikash Nehra & others Vs. State of Haryana & others or any other writ/court case pending in Hon'ble Punjab and Haryana High Court or in Hon'ble Supreme Court of India or in any other High Court of any State.
 2. The candidates who have been registered on the admission web portal opened from 8:00 AM on 27.05.2017 to 01:00 PM on 30.5.2017 with lowered criteria as notified by NEET shall also be considered for the 2nd round of counseling only after exhausting the list of already registered candidates who had applied on the admission web portal upto 08.4.2017.
 3. All admissions in Maharishi Markandeshwar University Mullana, Ambala will be done in compliance with the interim orders dated 04.05.2017 of the Hon'ble Supreme Court of India in Writ Petition Civil No.244 of 2017 titled 'Education Promotion Society of India & Ors vs. Union of India & Ors'.
