Further schedule regarding documents verification will be uploaded in due course of time.

- a) The Candidates who have joined on the allotted seats in the first round of counseling shall have to give their willingness/option to upgrade themselves in the second round of counseling online otherwise they shall not be considered eligible for the second round of counseling.
- b) Already registered candidates can change their category or any other information in their already submitted application during Round-1 of counseling.
- c) The candidates who have been allotted seats in the first round but did not join the allotted seat will also have to give their willingness to participate and submit fresh choices for the second round.

d) The Candidates who have joined on the allotted seat in the first round shall have a right to already allotted seat and this shall be changed only if he/she gets an upgraded and opted seat during second round. However, the candidates who wish to participate in the 2nd round of online counseling will have to submit their preferences/choices afresh. Candidates, who have been allotted, seat in first round should give the fresh choices in order of preferences for the seats in which they wish to upgrade themselves.

Note: -

 The choice filled by the candidates for 1st Round of counseling shall be treated as null and void and the candidates have to fill fresh choices to be eligible in the Login ID of candidates for participating in 2nd Round of counseling.

2. As per Govt. instructions, the candidates who have appeared in CET-2 held on 28.02.2021 cannot participate in 2nd round of counseling. They will participate for counseling after completion of Mop Up round of CET-1.
