Note:a) All the candidates who apply for admission to above courses are directed to appear in the Entrance test and counselling in PGIDS Rohtak on the date and time mentioned above.

b) All the Govt. Instructions and university rules in force shall be applicable for admission process may be downloaded from www.uhsr.ac.in

No separate letter for entrance test & counselling shall be issued.

c) In case, sufficient number of applications for admission to Dental Hygienist/ Dental Mechanic course are not received, then the admissions may be made on 10+2 merit.

Provisional Admission to Entrance Examination:

A candidate whose result has not been announced by date fixed for the entrance examination can also apply and appear in the examination provisionally. However, he/she will have to produce proof of his/her having passed the examination on the basis of which he/she claims eligibility to appear in the entrance examination by the date of the counselling to be held for final selections of the candidates. A candidate who fails to produce the original certificates/ mark sheets and other certificates on the basis of which he/ she is claiming to be eligible for admission to the course even at the time of counselling shall not be considered for admission even if he/she has been placed in the merit list.

The candidate who has not passed his/her qualifying examination in full on the date of first counselling shall not be eligible.

ELIGIBILITY CONDITIONS

- A. The Indian Citizen of following categories will be eligible for admission to Dental Hygienist Diploma Course/ Dental Mechanic Diploma Course:
 - i) The candidates, who are bonafide residents of Haryana as per instructions issued by the Chief Secretary to Govt. Haryana Chandigarh vide letterNo.62/1795-6GS1 dated 3.10.96 Annexure-2, U.O. No. 62/27/2003 6 GSI dated 29.07.2003 Annexure-3 and submit relevant certificate of bonafide residents as laid down in letter no.22/28/2003-3GS-III dated 30.1.2004 Annexure 4.
 - The children/wards (if parents are not living)/dependents of the employees of Indian Defense Services/Para-Military Forces belonging to Haryana State at the time of entry into service as per their service record. (Such candidates will submit a certificate in the proforma given inAnnexure-5 from the Officer duly authorized by the Army/Navy/Air Force/concerned Para-Military Forces Headquarters, as the case maybe).
 - iii) The children/wards (if parents are not living)/ dependents of Exemployees of Indian Defense Services/Para-Military Forces belonging to Haryana State at the time of entry into service as per their service record who retired from service on or after first. April of the preceding year of admission. (Such candidates will submit a certificate in the proforma given in Annexure-13 from the Officer duly authorized by the Army/ Navy/Air Force/concerned Para-Military Force Headquarters, as the case may be).
 - iv) The children/wards (if parents are not living)/dependents of Exemployees of Indian Defense Services/Para-Military Forces belonging to Haryana State at the time of entry into service as per their service record, provided the candidate has studied 10+2 as a regular candidate in a recognized institution in Haryana. (Such candidates will submit a certificate in the proforma given in Annexure-13 from the Officer duly authorized by the Army/Navy/Air Force/concerned Para-Military Forces Headquarters, as the case may be and also a certificate to the effect that he/she has studied 10+2 as a regular candidate in a recognized institution in Haryana from the Principal/Head of the Institution last attended in the proforma given in Annexure-14.
 - B. The candidates should also fulfill the following minimum conditions to appear in the Entrance Examination:-
 - (i) She/he will attain the age of 17 years or more on the date of 1st counseling.
 Note: The age shall be determined as per entry in the Matriculation/Higher Secondary or its equivalent Certificate.

PROCEDURE FOR ADMISSION:

Eligibility

- The candidate must have passed the following examinations: -(i)
 - A candidate should have passed 10+2 or equivalent examination with Physics, Chemistry, Biology and English.

Note:

1. The list of the examinations recognized as equivalent to 10+2 examinations of Board of School Education, Haryana is available in the Academic Branch, Univ. of Health Sciences, Rohtak.

2. The candidates passing qualifying examination from National Open School Shall also be eligible provided they fulfill the eligibility conditions.

The duration of course leading to the award of Diploma in **Duration of Course: -**

Dental Hygienist or Diploma in Dental Mechanic Course shall be for a period of two years. This two years course will

consists of 1st & 2nd academic sessions.

For appearing in examination a student will have to attend atleast 75% of the working days. However, for getting diploma/certificate he/she will have to complete full two years duration by repeating the period of absence, if any. The name of the student (s) who remain (s) absent from classes for more than 15 days at a stretch will be struck off from the College rolls without any notice. During the course of studies there shall be no vacation.

Students will be permitted vacations as permissible to other under graduate course

GENERAL INSTRUCTIONS

- 1. The reservation policy is subject to revision/State Government decision/court decisions and the same as applicable on the last date of submission of admission form shall be followed.
- All candidates belonging to the Scheduled Castes/Scheduled Tribes and Backward Classes etc. must submit a certificate from the competent authority showing that they belong to these classes/castes, as given in Annexure-4. All such Certificates should be only as per the proforma issued by the competent authority as prescribed by Haryana Govt. vide letter no. 22/28/2003-3GS-III dated 30.01.2004. Certificates issued by other than the prescribed authority shall not be
- As per Haryana Govt. Letter No. 22/8/2004-3GSIII dated 7.6.2007 there would be no distinction between SC-A & SC-B category and 20% seats shall be reserved for Scheduled Caste candidates
- If the seats from BC Block-A are not filled up, these may be filled from BC Block-B.
- Competition for reserved seats will be amongst the candidates belonging to the categories for which the seats have been reserved. Reserved seats remaining vacant on account of nonavailability of eligible candidates would be placed under 'Open Merit' seats.
- 6. List of Backward Classes notified by the State Govt. is available at Annexure-10 and also circular No. 1170-SW(1)-95 dated 7.6.95 for excluding socially advanced persons/sections (creamy layer) from Backward Classes is available at Annexure- 11 and clarification regarding issuance of certificate to Haryana Backward Classes given by the Haryana Govt. vide Letter No. 22.36/2000-3G.S.III dated 9th August, 2000 is at Annexure-12.
- Only Dependents of Freedom Fighters (FF) who wish to be considered for reservation as such must submit a certificate from the Competent Authority (Annexure-8) alongwith undertaking (Annexure -9)
- Only candidates having locomotor disability of lower limbs between 50% to 70% but otherwise medically fit for admission to the course will be considered for admission as physically handicapped. In case candidates are not available in the category then only candidates with disability of lower limbs between 40-50% may be considered for admission as per Govt. of India, Ministry of Health & Family Welfare, Nirman Bhawan, New Delhi, letter No. C.18018/2/2009-ME(P.1) dt. 17.2.2009 (Certificate as in (Annexure-6). The applicant in PH category should have to produce only the certificate of disability certificate issued by Medical Board, PGIMS, Rohtak at the time of counseling. No other medical certificate shall be valid.
- Children/Wards of Military personnel (including personnel of para-military Forces) killed in action or permanently disabled in action and boarded out from the services or Ex-servicemen and their wards will be considered for reservation as Ex-servicemen and their wards (Annexure-7).
- 10 A candidate who applies either for reserved category or for both reserved and open categories will be considered first in open category. In case he is not selected in open category, he will be considered for reserved category. In case a candidate does not fill up his reserve category in his application form, he/she will not be subsequently considered for admission against that
- 11 A candidate who applies for and qualifies for admission in more than one reserved category will be asked to exercise his choice at the time of counselling. Institutional preference which the candidate exercised at the time of counselling will be considered final.

Distribution of seats for Admission to Diploma of DH & DM at PGIDS, Rohtak

The seat distribution being adopted by Pt. B.D. Sharma, University of Health Sciences, Rohtak on the recommendations of the committee and approved by the office of director, medical Education & Research, Haryana vide Memo No. DMER/202/4435 Dated 15.05.2020 may also be implemented for these Dental Hygienist and Dental mechanic Diploma Course being run by PGIDS, Rohtak for the admission year 2022-23. Moreover, 10% seats of total may be reserved for EWS Category first and after that the distribution may be made. So, the distribution of seats may be observed as under:-

Note:1 Final distribution of seats will be displayed at the time of counseling procedure for submission of applications:-

(i) A copy of prospectus containing application form is available on university website and can be downloaded from the university website www.uhsr.ac.in and filled form may be submitted with Demand Draft of Rs. 500/- for General Category, EWS & for SC ,SC-D & BC of Haryana of Rs. 125/-. infavour of, Principal PGIDS Rohtak, payable at Rohtak.

Application for admission must be accompanied by the following:-

- (i) Certificate of having studied in Haryana in class X, XI and XII from the Institution last attended as per proforma in **Annexure-1**.
- (ii) Certificate pertaining to claims for reservations (if claimed) Scheduled Castes & Backward Classes (Annexure- 4).
 - (iii) Note: Candidate shall have to produce all the original certificates at the time of counselling, failing which he/she shall be rejected.

Instructions for curbing ragging:

Ragging in educational institutions is banned and any one indulging in ragging is likely to be punishedappropriately, which punishment may include expulsion from the institution, suspension from theinstitution or classes for a limited period or fine with a public apology. The punishment may also takeshape of (i) withholding scholarships or other benefits (ii) debarring from representation in events (iii) withholding results (iv) suspension or expulsion from hostel or mess, and the like. If the individuals committing or abetting ragging are not/cannot be identified, collective punishment can be awarded toact as a deterrent.

The following will be termed as the Act of Ragging:

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other students, indulging in rowdy or indisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear orapprehension thereof in freshers or junior students or asking the students to do any act or performsomething which such students will not do in the ordinary course and which has the effect of causing organerating a sense of shame or embarrassment so as to adversely effect the physique or psyche of afresher or a junior student.

Note:

Besides above, the candidates would also observe the following instructions:-

- It must be noted by the candidates/parents/guardian etc. that ragging is banned in theinstitutions and in case anyone indulging in ragging is liable to be punished appropriately including expulsion i) from the Institution and/or imprisonment upto 3 years, and /or fine upto 25,000/-.
- The concerned Institution will have the right that to prevent/prohibition of ragging under Act/Ordinance and if any, candidate admitted to the course found indulging in ragging will ii) becognizable offence and really means business and the Institutes will not hesitate to take sternaction against the offenders.
- A candidate admitted to the course in an Institution shall submit an undertaking duly signed iii) byhim/her and countersigned by his/her parents/guardian at the time of admission to the effectthat he/she is fully aware of the law regarding ragging as well as the punishment and that he/she if found guilty on this account is liable to be punished appropriately. Similar undertaking shallalso be furnished by the parents/guardian that they are fully aware and noted the law in this regard and agrees to abide by the punishment meted out to his/her ward in case their ward, ifadmitted to the course is found guilty of ragging as per ANNEXURE-21.
- Undertaking of similar nature as given under Sr. No. iii & above shall also be obtained from iv) theadmitted candidates in the application form for admission to the Hostels as well.
- As per the order of the Hon'ble Supreme Court of India dated 16.05.2007 which is v) reproducedbelow: "If any incident of ragging comes to the notice of the authority, the concerned student shall begiven liberty to explain and if his explanation is not found satisfactory, the authority

wouldexpel him from the institution".

Every student for the purpose of his/her admission shall furnish a Character Certificatefrom the vi) institutions wherefrom he/she has passed his qualifying examination, whichwould mention the status of his/her behavioural pattern specially in terms as to whetherhe/she has displayed persistent violent or aggressive behaviour or any desire to harmothers(Annexure 1).

EXTRACT OF ORDINANCE ON MAINTENANCE OF DISCIPLINE AMONG STUDENTS OF Postgraduate Institute of Dental Sciences, Rohtak (HARYANA)

Prohibition of ragging and penalties thereof

- Ragging in any form shall be strictly prohibited within the premises of the University, acollege or an institution, as the case may be, or in any part of the University system as well ason public (1) transport or at any other place, public or private.
- Any individual or collective Act or practice of ragging shall constitute an act of grossindiscipline (2) and shall be dealt with under the provisions of this ordinance.
- Ragging for the purposes of this ordinance, shall ordinarily mean any act, conduct or practiceby (3) which the dominant power or status of senior students is brought to bear upon the students who are in any way considered junior or inferior by the former and includes individual orcollective acts as practices which -
 - Involve physical assault or threat to use physical force; (a)
 - Violate the status, dignity and honour of students, in particular Women students and (b) those belonging to scheduled caste or a scheduled tribe;
 - Expose students to ridicule or contempt or commit an act which may lower their self (c) esteem; and
 - Entail verbal abuse, mental or physical torture, aggression, corporal punishment, (d) harassment, trauma, indecent gesture and obscene behaviour.
- The Dean of the Faculty, Chief Warden, Director of the institution or the Principal of thecollege, as the case may be shall take immediate action on the receipt of any information thatragging has (4) taken place or is likely to take place.
- Notwithstanding anything contained in clause (4), the chairman of the Board of Discipline (5) ofUniversity and its maintained college or the chairman of the Board of Discipline of an affiliated college or institution may also suo moto inquire into any incident of ragging or likelihood ofsuch incident and make a report to the Vice- Chancellor or Director/ Principal of the affiliatedcollege/ institution, as the case may be, clearly pinpointing, among other details, the identityof the student or the students who a were involved in the incident the nature of the incident.
- The chairman of the Board of Discipline may also submit an interim report to the Vice-Chancellor (6) in the case of University and its maintained colleges or to the Principal/ Directorof the affiliated colleges, as the case may be, establishing the identity of the perpetrators ofragging and the nature of the incident.
- If the chairman of a Board of Discipline is satisfied that for any reason, to be recorded inwriting, it is not feasible to hold and inquiry referred to in clauses (4) and (5), he may soadvise the Vice-(7) Chancellor or Director/ Principal of the affiliated college/ institution as thecase may be accordingly.
- Where the Vice-Chancellor or the Director/ Principal in case of affiliated colleges is satisfied,on receipt of a recommendation to this effect or otherwise, that it is not expedient to hold aninquiry (8) into an incident of ragging, he shall order accordingly for reasons to be recorded inwriting.

Subject: "Bonafide residents of Haryana - Guidelines regarding".

I am directed to invite your attention to Haryana Govt. letters noted in the margin on the subjectnoted above vide which the instructions were issued regarding simplification of procedure for obtaining the educational admission to of certificate of Domicile for the purpose (including technical/medical institution). The matter has been reconsidered in the light of judgment delivered bythe Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain vs. Union of India and others reportedas AIR 1984-SC-1421, wherein it has been held that instead of the word 'Domicile' the word 'Resident' beused in the instructions issued by the State Government and it has been decided to revise the Government instructions. Henceforth, the following categories of persons would be eligible for the grant of ResidentCertificate: -

- Candidates, who have passed the examination qualifying there for selection in an institution from i) a school/college in Haryana.
- Children / Wards (if parents are not living) / Dependents: ii)
- of the regular employees of Haryana Stateposted in or outside Haryana State or working (a)
- of the regular employees of the statutory bodies/corporations established by or under an act of the State of Haryana who are posted in Chandigarh or in Haryana or outside Haryana. (b)
- of the regular employees of the Government of India posted in Chandigarh or in Haryana (c) inconnection with the affairs of the Haryana Government;
- Children/wards (if parents not living)/dependents of persons who after retirement have permanentlysettled in Haryana and draw their pensions from the treasuries situated in the State iii)
- Children/wards (if parents are not living)/dependents of pensioners of Haryana Governmentirrespective of the fact that the original home of the retiree is in a state other than iv) Haryana or hehas settled after retirement in or outside Haryana;
- Children/Wards (if parents are not living)/dependents of persons, who have permanent home inHaryana and include persons who have been residing in Haryana for a period of not less than v) 15years or who have permanent home in Haryana but on account of their occupation they are livingoutside Haryana;

- The wives of such persons who are bonafide residents of Haryana irrespective of the fact that vi) theyhad belonged to any other State before marriage;
- Persons who were born in Haryana and produce a certificate to that effect; provided that theparents/guardians (if parents are not living) of persons belonging to any one of the above vii) mentionedcategories are:

 - b) Produce an affidavit to the effect that they or their children/wards (if parents are notliving)/dependents have not obtained the benefit of Resident in any other State.
- All candidates claiming to be bonafide residents of Haryana should produce a Haryana ResidentCertificate signed by the District Magistrate/General Assistant to Deputy Commissioner 2. or Sub-Divisional Officer (Civil) of the District/Sub-Divisions to which the candidates belong. ResidentCertificates in respect of elsewhere or in respect of the Children/Wards/Dependents of HaryanaGovt. employees who are posted at Chandigarh, Delhi or elsewhere or in respect of Children /Wards/ Dependents of pensioners of Haryana Govt. or in respect of the Children/Wards/Department of the employees of the Government of India posted at Chandigarh or in Haryana inconnection with the affairs of Haryana Government, or in respect of Children/Wards/Dependentsof the employees and retirees of the Statutory Bodies/Corporations of Haryana established by orunder an Act of the State of Haryana or a Central Act and located at Chandigarh, Haryana oroutside Haryana, should be by their respective Heads of Departments.
- (including medical and Candidates seeking admission in educational institutions technicalinstitutions) located in Haryana, may not be required to produce Resident Certificate, if 3. they havepassed the examination from a school/college situated in Haryana. For this purpose, a certificateof the Principal/Headmaster from concerned institution where the children/wards studied lastshould be considered sufficient. The Principal/Headmaster of the institution shall be competentto issue such certificate, which should be sufficient.
- If a candidate is admitted on the basis of claim that he belongs to the State of Haryana but at anysubsequent time is discovered that his claim was false, the student shall be removed from 4. theinstitution, all fees and other dues paid up to the date of such removal shall be confiscated. ThePrincipal/Headmaster may take such other action against the student and his/her parents/guardians as he may deem proper in the circumstances of any particular case.
- For the purpose of uniformity for issuing certificate of Residence in the case of various categoriesto be issued by the competent Authorities, proformas have been prescribed which are 5.

Subject: "Streamlining the procedure in the offices regarding issuing of Resident /Income Certificates and the caste certificate to Scheduled Castes and Backward Classes".

I am directed to invite your attention to Haryana Government letters Nos. 62/17/95-2G.S.III, dated 03.10.96, No. 22/51/93-3G.S.III, dated 12.8.93 and even No. dated 14.10.97 on the subject noted above wherein instructions regarding the caste certificates (SC/BC/OBC), and Resident certificates have been issued.

2. The policy has been reviewed keeping in view the various courts judgments and the hardships caused to the individuals in obtaining above quoted certificates. Government is of the view that the procedure be institutionalized by delegating powers at proper level for ensuring speedy disposal of work without any harassment or exploitation. The present modification of the policy also aims at simplifying the procedure for obtaining certificate by an individual falling under the reserved categories.

The matter has also been reconsidered in depth by the State Government in view of the problems being faced by the Government employees in obtaining these certificates. With a view to improve the existing system in issuing various certificates, it has been decided by the Government that henceforth Circle Revenue Officers (Tehsildar/Naib Tehsildar-cum-Executive Magistrate) concerned will be authorized to issue Resident as well as Caste Certificates (SC/BC/OBC) after getting the verification done through the subordinate revenue staff in case of applicants residing in the rural area and through the Executive Officer/Secretary of the concerned Municipal Committee/Municipal Council/Municipal Corporation concerned in case of applicants residing in urban area. It has further been decided that in case of Haryana Government employees serving in the offices located at Chandigarh/Panchkula and residing at Chandigarh/Panchkula, the Resident certificates and caste certificate to SC/BC employees and for their children, may be issued by their respective Heads of Departments also.

 The validity of Resident Certificate issued by the competent authority shall be as long as the holder of this certificate maintains his residential address in Haryana State.

4. SC certificate once issued shall be valid as long as the caste is not removed from the Schedule of the Constitution and BC certificate shall be valid for life from the date of issue of the certificate or till the applicant does not fall into creamy layer category as defined from time to time. The applicant applying for BC certificate would also submit a self declaration on simple paper that he does not fall under creamy layer category. The format for this declaration is given at Annexure 'A' However, if the certificate has been obtained by fraud or misrepresentation or concealment offacts or by some other means, the said certificate shall be declared as invalid/non-est and benefittaken by the applicant will be withdrawn and a criminal case shall be registered against theapplicant misrepresenting the facts as well as against the guilty officers/officials, if any. Inaddition, Social Justice & Empowerment Department, Haryana is being, directed to finalize themodalities and procedure to Constitute the Scrutiny Committee.

The files relating to Caste and Resident certificate shall be retained for 10 years and Registershall be retained permanently. The proforma of the application form, Register and SC/BC certificatesprescribed by the Government shall be followed by all the Departments/Institutions in letter andspirit as it has come to the notice of the Govt. that some Departments/Institutions demand suchcertificates in proforma which are at variance with the proforma in which these certificates arebeing issued by the competent authorities (Tehsildar / Naib Tehsildar/HODs). It is, therefore, decided that the Departments/Institutions shall accept these certificates only in the proforma inwhich these are being issued by the competent authorities which have been prescribed by theGovt. itself (copy enclosed).

To make institutional arrangements, it has also been decided that in future the Resident and Castecertificates will be issued to all the students studying in class 8th every year as per the timeschedule given below:-

Filling of application form by the parents/students. 1st Nov. To 10th Nov. Every year. ii.
 Verificationby (a) Sarpanch/ Namberdar in case of rural areas and Municipal Councilors in case of Urbanareas.

- (b) Verification by Patwari in case of rural areas /EO/Secy.(MC) any other officer/officialauthorized by the local body for the purpose in case of urban areas. Upto 30th November everyyear.
- (c) Head Teacher/Head Master Upto 15th Dec. iii. Forwarding of application to CRO by HeadTeacher/Head Master 31st Dec. iv. Verification & issue of certificate by CRO Upto 31st Ianuary year.
- All application forms of a particular School may be sent to the Tehsildar / Naib Tehsildarconcerned preferably at one go so that the certificates are issued and sent back to the Headmasters of Government Schools/Private Schools for distribution to the concerned students. The Head Teacher/Head Master shall be responsible for getting the application forms filledand files prepared of all the students presently studying in Class-VIII to XII will be issuedthese certificates during the months of January, 2004 to March, 2004. The schedule will be finalized by the concerned Deputy Commissioner in this regard.
- 7. It has been further decided that in case of SC/BC students claiming benefit under variouswelfare schemes upto Class IX, the benefits will be given by the Head Master/Head Teacherafter getting the verification done from Sarpanch/ Namberdar/MC and a caste certificateissued by the CRO (Tehsildar / Naib Tehsildar) may not be demanded for this purpose by the School authorities.
- The matter regarding issue of income certificate to the students for claiming various benefitsin educational institutions has been considered and it has been decided that in future theincome certificate for educational purpose will be issued by the CRO (Tehsildar / Naib Tehsildarconcerned) and income certificate for other purposes by the SDO (C) concerned taking intoaccount income of the applicant from various sources including agriculture, trade, profession,salary etc. The verification will be got done through the subordinate revenue staff in case ofapplicants residing in rural areas and through the Executive Officers/Secretary of theconcerned Municipal Committee/Council/Municipal Corporation in case of applicantsresiding in urban areas.
- It has also been brought to the notice of the Government that when posts are advertised, fairlylarge number of candidates apply for such posts and Haryana Public Service Commission/HaryanaStaff Selection Commission /Department demand attested copies of Resident/Caste certificatesand other documents from the candidates. This creates not only financial problems for theunemployed youths but also increases the work load in the offices. Similar is the position in caseof admission to educational/professional Engineering institutions. To give relief to the public, ithas been decided that at the time of applying for job or for admission in educational institutionsincluding technical/professional institutions etc. self attested photo copy of the certificate about he residence and caste status shall be sufficient and at the time of final interview/selection,original papers including castes and Resident certificate issued by the concerned authoritiesmay be obtained/examined/inspected by departments/institutions and attestedcopies thereof be kept in record. The fact may also be cross checked/verified at the time ofverification of the antecedents of the applicants before he/she joins the Government service. Similar practice will be followed for degrees/mark sheets/other certificates of academic qualifications. Necessary action to amend/revise the application form in this regard shall betaken by Haryana Public Service Commission/ Haryana Staff Selection Commission/Head of theDepartments/Universities etc. at their own level under intimation to the Government.

These instructions may be brought to the knowledge of all for strict compliance.

Sub: Exclusion of socially advanced persons/sections-(Creamy Layer) from BackwardClasses.

Sir

I am directed to invite your attention to the subject mentioned above and to state thatfollowing the Supreme Court judgment in the Indira Sawhney and others versus Union ofIndia case, the Haryana Government vide notification dated 12.10.1993 had set up the HaryanaSecond Backward Classes Commission. The terms of reference of this Commission were toentertain, examine and recommend upon requests for inclusion and complaints of over-inclusion and under-inclusion in the list of backward Classes. Vide notification dated 26-5-1994, the Commission was also assigned the function of specifying the basis, applying therelevant and requisite socio-economic criteria to exclude socially advanced persons/sections(Creamy Layer) from Backward Classes.

In its report submitted on 16.5.1995, the Haryana Second Backward Classes Commissionhad recommended the criteria for excluding socially advanced persons/sections (CreamyLayer) from Backward Classes. After considering these recommendations, the Governmenthas decided that the benefit of reservation shall not apply to persons/sections mentionedin Annexure -11 A, which is enclosed.

All the departments are requested to bring the above instructions to the notice of allthe Heads of Departments and appointing authorities under their control for necessary compliance.

DESCRIPTION OF CATEGORY TO WHOM RULE OF EXCLUSION WILL APPLY

I. CONSTITUTIONAL POSTS

Son(s) and daughter(s) of -

- a) President of India;
- b) Vice President of India;
- c) Judges of the Supreme Court and of the High
- d) Chairman and Members of UPSC and of the State Public Service Commission; Chief Election Commissioner; Comptroller and Auditor General of India:

A-Group Class-I

- a) Sons and daughters of parents either of whom or both of whom are Class-I Officers and such parent(s) dies/die or suffer permanent incapacitation.
- b) A lady belonging to OBC Category has got married to a Class-I Officer and may herself like to apply for a job.

B. Group B/Class II

Son(s) and daughter(s) of

- a) parents both of whom are Class-II Officers.
- b) parents of whom only the husband is a Class-I Officer and he gets into Class-I at the age of 40 or earlier.
- c) parents, both of whom are Class-II Officers and one of them dies or suffers permanent incapacitation and either one of them has had the benefit of employment in any International Organization like U.N., I.M.F., World Bank, etc. for a period of not less than 5 years before such death or permanent incapacitation;

d) parents of whom the husband is a Class-I Officer (direct recruit or pre-forty promoted) and the wife is a Class II officer and the wife dies or suffers permanent incapacitation; and e) parents, of whom the wife is a Class-I Officer (Direct Recruit or pre-forty promoted) and the husband is a Class-II Officer & the husband dies or suffers permanent incapacitation. Provided that the rule of exclusion shall not apply in the following cases:-Sons and daughters of a) Parents both of whom are Class-II Officers and one of them dies or suffers permanent incapacitation. b) Parents, both of whom are Class-II Officers and both of them die or suffer permanent incapacitation, even though either of them has had the benefit of employment in any International Organization like U.N., I.M.F., World Bank, etc. for a period of not less than 5 years before their death or permanent incapacitation.

C. Employees in Public Sector Undertaking etc.

The criteria enumerated in A & B above in this Category will apply mutatis mutandi to officers holding equivalent or comparable posts in PSUs, Banks, Insurance Organizations, Universities etc. pending the evaluation of the posts on equivalent or comparable basis in these institutions, the criteria specified in Category-V below will apply to the officers in these Institutions.

III ARMED FORCES

Sons(s) and daughter(s) of parents either or both of whom is or are in the rank of colonel and above in the army and to equivalent posts in the Navy and the Air Force and the Para Military Forces:

Provided that-

- i) If the wife of an Armed Forces Officer is herself in the Armed Forces (i.e. the category under consideration) the rule of exclusion will apply only when she herself has reached the rank of colonel;
- the service ranks below colonel of husband and wife shall not be clubbed together;
- iii) If the wife of an officer in the Armed Forces is in Civil employment, this will not be taken into account for applying the rule of exclusion unless she falls in the service category under item No.II in which case the criteria and conditions enumerated therein will apply to her independently.

IV PROPERTY OWNERS

Son(s) and daughter(s) of persons belonging to a family (father, mother and minor children) which owns land more than land permissible under the Ceiling Act of Haryana State.

V INCOME/WEALTH TAX

- Son(s) and daughter(s) of-
- Persons having gross annual income of Rs.2.50 a) Lacs or above or possessing wealth above the exemption limit as prescribed in the Wealth Tax Act for a period of three consecutive years.
- Persons in Categories I,II,III& IV who are not b) disentitled to the benefit of reservation but have Income from other sources of Wealth which will bring them within the income/wealth criteria mentioned in (a) above.

Explanation:

- Income from salaries or agricultural land shall not be clubbed;
- The income criteria in terms of rupee will be modified taking into account thechange in its value every three years. If the situation, however, so demands, theinterrugnum may be less. ii)
- Where the husband is in some profession and the wife is in a Class-II or lower grade employment the income/wealth/Criterion will apply only on the basis ofthe husband's iii)
- If the wife is in any profession and the husband is in employment in a Class-II orlower rank post, then the income/wealth criterion will apply only on the basis of thewife's income and the iv) husband's income will not be clubbed with it.

Explanation: Wherever, the expression, 'permanent incapacitation' occurs in this scheduleit shall mean incapacitation which results in putting an Officer out of service.

I am directed to invite your attention to the Govt. of Haryana, Social Welfare Departmentletter No. 1170-SW (1) 95, dated 7.6.95 on the subject noted above, therein criteria was laiddown to assess the creamy layer persons of Haryana Backward Classes in Haryana State. The Backward Classes of Haryana are facing difficulty in obtaining the Backward Classescertificate from the certificate issuing authority due to some understanding in the instructionsdated 7.6.95. After careful consideration the Govt. of Haryana has decided to issue clearcut directions to all the Heads of Department's and Deputy Commissioners in the state for issuing Backward Classes Certificate without any further delay.

It is clarified that the income from salary will not be taken into account for the purposeof income/wealth tax in respect of service category and while calculating income or wealthtest of the Government employee of Backward Classes who is not covered under Annexure-A, description of categories No. I, II (a,b,c,d) and III & IV, hence becoming entitled for thebenefit of reservation under Backward Classes category, his salary should not be included but his other sources of income/wealth be included for income/wealth tax.

All the departments are requested to bring the above instructions to the notice of allthe Head of Departments and appointing authorities under their control for necessary compliance.

In order to remove some difficulties facing the physically handicappedcandidates, it has been decided that for the purpose of admission in Government as wellas, in Government aided Educational/Professional/Medical/Engineering/I.T.I.'s/TechnicalEducational Institutions and Colleges, there will be 3% reservation for physicallyhandicapped (1% for blindness or low vision, 1% for hearing impairment and 1% forlocomotor disability or cerebral palsy). But in the event of the quota reserved for physicallyhandicapped candidates, it may be offered to the Ex-servicemen and their wards, (1%) andthe dependents of freedom fighters (1%).

Subject :- Reservation of posts for Scheduled Castes, Backward Classes under the services of HaryanaState. Sir.

I am directed to refer to Haryana Government Letter No. 22/55/90-3GS-III, dated 9-11-1994 on the subject noted above which interalia laid down that for the purpose of reservation in services, Scheduled Castes in Haryana would be put in two categories i.e. Block A and Block B in directrecruitment. These instructions had been challenged in the Hon'ble Punjab & Haryana High Court byway of Writ Petition 398 of 2004-Gajay Singh Muwal Vs. State of Haryana and other 3 Civil WritPetitions. The Hon'ble Court vide its common judgment/orders dated 6-07-2006 has quashed theabove instructions dated 9-11-1994 in the following terms:

"We accordingly, find that the present controversy is fully covered by the decision of SupremeCourt in the case E.V. Chinnaiah's case (Supra). We, accordingly, would quash the Notification No. 22/55/90-3GS-III, dated 9-11-1994 holding the same to be ultravires of the Constitution."

The State Government has filed a Special Leave Petition CC No. 1789 of 2007-State of HaryanaVs. Gajay Singh Muwal alongwith an application for staying the operation of the judgment/ordersdated 6-07-2006 of the Hon'ble High Court in the said case. Similar SLPs have been filed by someprivate respondents also. However, these SLPs have neither been listed for hearing nor any stay hasbeen granted by the Hon'ble Supreme Court in India, so far.

Under these circumstances the State Government on reconsideration of the matter, has decided to withdraw instructions bearing No. 22/55/90-3GS-III, dated 9-11-1994 subject to the final decision of the Hon'ble Supreme Court in the SLPs referred to above. Consequently, there will be no categorization of the Scheduled Caste into A and B blocks. The vacancies meant for direct recruitment to reserved category of Scheduled Castes will be notified to the recruiting agencies without categorization of Scheduled Castes in A & B Blocks.

Similarly, the Govt. instructions bearing No. 22/34/98-3GS-III, dated 19-3-1999 and evennumber dated 5-5-1999 and letter No. 22/89/97-3GS-III dated 7-08-2000 regarding admissions inGovt. as well as in Govt. aided/self financing/Educational/Professional/Medical/Engineering/ITIs/Technical Educational Institutions and colleges will be deemed to have been modified to the extentindicated above.

It is requested that these instructions may be brought to the notice of all concerned for strict compliance.

- 2. In this regard attention is invited towards the instructions issued by the Haryana Govt.vide letter No. 22/89/97-3 GS III, dated 7th August, 2000. IN these instructions, there is a provision of 3% reservation for Physical Handicapped, but in the event of the quota reserved for PhysicallyHandicapped remaining non-utilized due to non-availability for suitable category ofhandicapped candidates, 1% has been offered to the Ex-Servicemen and their wards and 1% tothe dependents of freedom fighters.

The Govt. has decided that the wards of those killed in "Operation Vijay" can be coveredunder the provisions of the above quoted instructions, because no separate reservation can begiven, as there is already 50% vertical reservation for the admission in Educational Technical &Engineering Institutions.

3. Physically handicapped 3% In the event of quota reserved for physically handicapped remainunutilized due to non availability for suitable category of handicapped candidates, it may be offered to the Ex-servicemen and their wards (1%) and the dependents of Freedom Fighters (1%)

On further consideration of the matter, it has been decided to allow 3% horizontal reservation to Ex-serviceman/ freedom fighters and their dependents by proving reservation within reservation of1% of general category, 1% out of scheduled castes and 1% from backward classes category for admissionto the various educational institutions of the Government and Government aided/self financing colleges/institutes located in Haryana. As far as block allocation in Block A and Block B of Scheduled Castes andBackward Classes categories is concerned, year-wise rotational system will be adopted. For example, ifblock A of scheduled castes and backward classes are given seats in the academic year 2006, the nextblock i.e. B Block of categories of scheduled castes and backward classes will be given seats in the nextacademic year i.e. 2007 and so on .

These instructions should be brought to the notice of all concerned working under your control for strict compliance.

Sir/ Madam,

I am directed to invite your kind attention towards Government instructions No. 3870-WGI-ASOII-64/20069 dated 6th/9th October, 1964 whereby the candidates of Scheduled Castes and Scheduled Tribesprovided 5% reduction in marks in the minimum eligibility qualification for admissions in various courses.

It has come to the notice of the Government that at present where a General Category Candidate isrequired to have 50% marks in a prescribed qualification for admission in any course, as per the aboveinstructions a reserve category candidate is required to have 45% marks giving him 5% reduction in theminimum qualification. Vide judgment of Hon'ble Supreme Court in civil Appeal No. 7084/2011, It has beenobserved that the practice is wrong and the relaxation of 5% should be reduced from the minimumrequired marks on a general category candidate for eg.:-

In a course, a general candidate requires to have 50% marks, than as per Govt. instructions bygiving 5% relaxation the minimum eligibility marks for a reserved caste candidate should be calculated asunder:-

Out of 100 Marks needs to less = 5Out of 1 Marks needs to less = 5 / 100Out of 50 marks needs to less = $5 / 100 \times 50 = 2.50$

Reservation for Economically Weaker Sections in Direct recruitment in Civil posts and services as well as in admissions in Government/Government Aided Educational Institutions in the State of Haryana.

I am directed to inform that government of India has notified "THE CONSTITUTION (ONE HUNDRED AND THIRD AMENDMENT) ACT, 2019" On 12th January, 2019 amending Article 15 & 16, which are now read as under:-

Amendment of article 15

In Article 15 of the Constitution, after clause (5), the following clause shall be inserted namely:-

- '(6) Nothing in this article or sub-clauses (g) of clause(1) of article 19 or clause (2) of article 29 shall prevent the State from making,-
 - (a) Any special provision for the advancement of any economically weaker sections of citizens other than the classes mentioned in clauses (4) and (5); and
 - (b) Any special provision for the advancement of any economically weaker sections of citizens other than the classes mentioned in clauses (4) and (5); in so far as such special provisions relate to their admission to educational institutions including private educational institutions, whether aided or unaided by the State, other than the minority educational institutions referred to in clause(1) of article 30, which in the case of reservation would be in addition to the existing reservations and subject to a maximum of ten per cent of the total seats in each category.

Explanation- For the purposes of this article and article 16, "economically weaker sections" shall be such as may be notified by the State from time to time on the basis of family income and other indicators of economic disadvantage."

Amendment of article 16

In Article 16 of the Constitution, after clause (5), the following clause shall be inserted, namely:-

"(6) Nothing in this article shall prevent the State from making any provision for the reservation of appointments or posts in favour of any economically weaker sections of citizens other than the classes mentioned in clause (4), in addition to the existing reservation and subject to a maximum of ten per cent of the posts in each category".

In the wake of above enabling provisions, State Government has considered the matter and decided to provide benefits of reservation on a preferential basis in Civil Posts in all the Departments/Boards/Corporations/Local Bodies

and in Admissions to Government/Government Aided Educational Institutions to those Economically Weaker Sections (EWSs) who are not covered under the existing scheme of reservation for the Scheduled Castes, Backward Classes (Block-A) and Backward Classes (Block-B).

2. QUANTUM OF RESERVATION:

The persons belonging to EWSs who are not covered under the existing scheme of reservation for Scheduled Castes, Backward Classes (Block-A) and Backward Classes (Block-B) shall get 10% reservation in direct recruitment to Group A,B,C and D posts in the Departments/Boards/Corporations/Local Bodies of Government of Haryana and also in admission to Government/Government Aided Educational Institutions in the State of Haryana.

- 3. EFFECTING RESERVATION-ROSTER POINT:
- Direct recruitment in case of Group-A & B
 Roster point No. 11-20-30-40-51-60-70-80-90 and 99
- 3.2 Direct recruitment in case of Group-C &D Roster point No. 4-14-24-34-43-53-66-76-83 and 94
- 3.3 Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog and will be filled from unreserved category.
- 3.4 Persons belonging to EWS selected against the quota for persons with benchmark disabilities/ex-servicemen shall be placed against the roster points earmarked for EWS.

4. CRITERIA OF INCOME & ASSESTS

- 4.1 Persons who are not covered under the existing scheme of reservation for Scheduled Caste, Backward Classes (Block-A) and Backward Classess (Block-B) and whose family has gross annual income below Rs. 6.00 lakh (Rupees six lakh only) are to be identified as EWSs for benefit of reservation Income shall also include income from all sources i.e. salary, agriculture, business, profession etc. for the financial year prior to the year of application.
- 4.2 Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-
 - 5 acres of agricultural land and above.
 - II. Residential flat of 1000 sq. ft. and above.
 - III. Residential plot of 100 sq. Yards and above in notified municipalities.
- IV. Residential plot of 200 sq. Yards and above in areas other than the notified municipalities.
- V. Total immovable assets owned are valued at Rs. One Crore or more.
- 4.3 The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
- The team "Family" for this purpose will include the person who applies for benefit of reservation, his/her parents, spouse as well as children and siblings below the age of 18 years.
- 5. INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:
- 5.1 The benefit of reservation under EWS can be availed upon production of an income and Asset Certificate issued by a Competent Authority. The Competent Authority for EWS Income and Asset Certificate shall be Tehsildar of the area where the applicant normally resides.
- 5.2 The prescribed format for EWS Income and Asset Certificate shall be as provided at Annexure-I.
- 5.3 The Officer who issues the certificate would do the same after carefully verifying all relevant documents following due process as prescribed by the State.
- 5.4 The crucial date for submitting Income and Asset Certificate by the candidate may be treated as the closing date for receipt of application for the post, except in cases where crucial date is fixed otherwise.
- 5.5 The appointing authorities should in the offer of appointment to the candidates claiming to be belonging to EWS, include the following clause:-
