## **Public Notice**

**Second round of counselling for admission to MD/MS/PG Diploma/ MDS Courses in all Government/ Government Aided/ Private Unaided Medical/ Dental Institutes including those under SGT University, Budhera, Gurugram (Private University) in the State of Haryana for the Academic Session 2018-19.**

It is for the information of all the eligible candidates for admission to PG courses for the academic session 2018-19 that in compliance with the order dated 03.05.2018 of the Hon'ble Supreme Court in Writ Petition (Civil) number 357 of 2018, the second round of counselling for admission to MD/MS/PG Diploma courses held on 01.05.2018 stands cancelled. - 1. The candidates who have registered afresh on the admission web-portal from 03/05/2018 to 06/05/2018 shall be considered only after the exhausting the merit list of candidates who have already registered themselves on the admission web-portal till 24/03/2018.**
  - 2. Failure to deposit the fee as mentioned above will lead to cancellation of the seat and the same shall be allotted to the next eligible candidate.**
