Mop-up round and walk in counseling for filling vacant seats for admission to MD/MS/PG Diploma/ MDS Courses in all Government/ Government Aided/ Private Unaided Medical/ Dental Institutes including those under SGT University, Budhera, Gurugram (Private University) in the State of Haryana for the Academic Session 2018-19.

It is for the information of all the eligible candidates desirous of seeking admission to PG courses for the academic session 2018-19 that in compliance with the order dated 25.05.2018 of the Hon'ble Supreme Court in Writ Petition (Civil) 556 of 2018, the State Government shall conduct another mop-up round and walk in counseling for admission to MD/MS/PG Diploma/MDS courses on 31.05.2018, 09.00 A.M. onwards in the campus of Pt. B.D. Sharma University of Health Sciences, Rohtak based on All India merit of NEET-PG 2018 and NEET-MDS 2018.

The admission web-portal for online fresh registration shall be opened from 09:00 AM on 26.05.2018 to 05.00 PM on 29.05.2018. All the students desirous of seeking admission to MD/MS/PG Diploma/MDS courses can register themselves online through web portal of Haryana Knowledge Corporation Limited (HKCL) – www.uhspgadmissions.in.

Final number of vacant/left over seats in each specialty under each category and in each institute shall be displayed at the time of counseling and will also be available on the admission webportal- www.uhspgadmissions.in and the web-portal of Pandit Bhagwat Dayal Sharma University of Health Sciences, Rohtak – www.uhsr.ac.in. The candidates should visit the above mentioned websites regularly for any updates.

Note:

- 1. All the candidates irrespective of whether registered earlier on the admission webportal, will have to register afresh on the admission web-portal again, failing which the candidate will lose his or her right to participate in the counselling.**
- 2. The candidates who shall walk in for counseling to be held on 31.05.2018 shall be considered only after exhausting the list of candidates registered on the admission web portal from 26.05.2018 to 29.05.2018.**
- 3. The candidates should report at the venue of counselling at 09.00 A.M alongwith all original documents and requisite fee.**
- 4. Failure to deposit the documents and fee on the spot as mentioned above will lead to cancellation of the seat and the same shall be allotted to the next eligible candidate.**
- 5. The Demand Draft should be in favour of Registrar, Pt. B.D. Sharma University of Health Sciences, Rohtak and will have to be submitted to the Chairman, Admission Committee at the time of counselling itself.**
- 6. The candidates who have already secured admissions elsewhere will not be permitted to resign and avail the opportunity of this counselling.**
