All the concerned are hereby informed that in compliance of orders of the Hon'ble High Court of Karnataka, at Bengaluru, passed in Writ Petition No 48891/2018(EDN-RES) & Writ Petition Nos. 36658/2019(EDN-RES) and 54782/2018(EDN-EX) on 08.03.2021, Pt. B. D. Sharma University of Health Sciences, Rohtak shall be re-conducting the Written Screening Test of Paper II of Master of Science in Dentistry (MSD) in Orthodontics on 21.06.2021(Monday) between 10:00 AM to 01:00 PM at Post Graduate Institute of Dental Sciences, Rohtak for the purpose of recognition of PG Dental qualification awarded by foreign Institutions /Authorities in respect of Indian students/citizens. **The scheme of examination and distribution of marks as notified by Dental Council of India shall be as under:-**

MDS/PG Diploma Paper- II

- I. Total Number of questions of the speciality concerned -150
- II. Duration of examination - 180 minutes/3 hours.
- III. For correct answer to the question one mark shall be awarded.
- IV. There shall be no negative marking.
- V. There is no provision of awarding of grace marks.
- VI. To qualify for appearing in the Viva-Voce examination, the candidate needs to secure a minimum of 50% of the maximum marks of the paper.
- VII. The standard of DCI Screening Test exam in respect of MDS/PG Diploma and BDS degree holder would be at par with the prescribed standard for Indian Universities.
- VIII. The MDS/PG Diploma-Viva-Voce Examination shall be of a maximum of 50 marks.
- IX. The candidate has to separately score 50% marks in the Viva-Voce examination.
