

NOTIFICATION

This is in continuation of the previous notification dated 14/02/2020 issued by the Pt. B. D. Sharma University of Health Sciences, Rohtak, regarding the conducting of Written Screening Test for recruitment of 447 Medical Officers in the Health Department, Haryana, that the University shall be conducting as per directions of Government of Haryana, on 01/03/2020 between 12.30 PM to 2.00 PM. All the concerned are hereby informed that the question paper for this examination shall be consisting of 100 multiple choice questions with 4 choices for each question, out of which one shall be most appropriate answer. Each question shall be of one mark and there will be no negative marking. The distribution of the questions in the question paper booklet for the above mentioned examination shall be as mentioned under:

The candidates shall be provided question paper booklets of either of the four series code i.e. A, B, C & D. The answer sheet shall be OMR based and consisting of two copies. The examinee appearing in the Written Screening Test must hand over the question paper booklet and the first copy of the OMR answer sheet to the invigilator on duty at the end of examination and the second copy can be retained by the candidate with him/her.

Sharma, University of Health Sciences, Rohtak, till 5:00 PM on 4 th of March, 2020, only through the email ID coe.uhsr@gmail.com An objection raised by any candidate through any means, other than the above mentioned email ID shall not be entertained by the University.
3.	5 th of March, 2020	Any objection, if so, received pertaining to the answer key of any question shall be assessed by an expert committee constituted for addressing the grievances.
4.	6 th of March, 2020	Uploading of the final answer key.
5.	7 th of March, 2020	Declaration of the result of the Written Screening Test.
