PUBLIC NOTICE FOR ADMISSION TO ANM, GNM & MPH(M) COURSES (EXTENDED STRAY ROUND-3)

The tentative schedule for **EXTENDED STRAY ROUND-3** of counseling for admission to ANM, GNM & MPH(M) courses in Government and Private Institutions located in the State of Haryana for the Academic Session 2025-26 is as under:-

2.	Display of Merit List and vacant seats	30.01.2026 (02:00 PM)
3.	Preferences locking/ Choice Filling	30.01.2026 (02:00 PM) to 30.01.2026 (upto 10:00 PM)
4.	Online Allotment of the Institute/Course	31.01.2026 (09:00AM)
5.	Verification of original documents for Eligibility/fees deposition & admit the students by Institute on online Web portal.	31.01.2026 upto 06:00 PM

Note:-

1. Fresh candidates can register for extended stray round-3 of counseling, if not registered in Round-1, Round-2, Mop-up Round, Stray Round, Extended Stray Round & Extended Stray Round-2.
2. The candidates who have already registered themselves upto Extended Stray Round-2 and wish to participate in the Extended Stray Round-3, shall not be required to register again.
3. **The seats allotted in Extended Stray Round-2 will not be considered in vacant seat matrix for Extended Stray Round-3, the candidates who have been allotted seats in Extended Stray Round-2 will be allowed to join in their respective allotted colleges as per schedule i.e. 31.01.2026 (04:00PM).**
4. The candidates, who have been allotted seats to them in the Mop-up Round and Stray Round, Extended Stray Round & Extended Stray Round-2 shall not be eligible to participate in the Extended Stray Round-3/further round of counselling (if any).
5. The candidates who have already "joined" on any seat allotted to them upto Extended Stray Round-2, shall not be eligible to participate in the Extended Stray Round-3/further round of counseling even after resignation.
6. The candidates will have to deposit the fee in the shape of Demand Draft/RTGS/NEFT to the allotted Institute directly.
7. Final number of seats under each category shall be displayed on the admission web portal i.e. <https://nursing.online-counselling.co>. before the start of counseling. The candidates should regularly visit this website for updates.
8. The choices filled by the candidates for the Round-1/Round-2/Mop-up Round/Stray Round/Extended Stray Round/ Extended Stray Round-2 of counseling shall be treated as null and void and the candidates will have to fill fresh choices for Extended Stray Round-3.
9. Reservation and relaxation in age etc. shall be provided to the candidates as per State Reservation Policy.
10. Any candidate who fails to deposit original documents and the requisite fees to the Institute as per the time prescribed in the schedule will not be considered and his/her claim to admission will be forfeited.
11. Registration fees shall be deposited by the candidate only through Net Banking/UPI and fees once deposited by way of any mode shall be Non-Refundable.
12. **Admissions shall be made to only those institutes which are recognized and approved for admission from INC/State Government /HN&NMC.**

13. After Document Verification the institutes will have to mandatorily admit the candidates online on the admission web portal who have been allocated seats, failing which the candidature of the candidate will not be considered. The Institutes should ensure to complete the online process timely and **NO REQUEST** regarding technical glitches/ over sightedness on online system will be entertained and concerned Institutes shall be solely responsible for the same.
14. **Candidate should ensure to register on the admission web portal themselves only and fill all details like Name, Father/Mother Name, DOB, Category, Educational Qualification, Subject, Percentile, Address, Mobile No. and e-mail Id etc. carefully. No claim shall be entertained on this ground subsequently.**
15. **Candidate should register with single registration /Login ID on admission web portal. If any candidate registers himself/herself by more than one registration/Login ID will not be considered in merit list and for seat allocation.**
16. If any institute fails to declare the vacancy position as per the specified date, such seats shall be considered filled and allotment to such seats shall not be made.
17. Under No circumstances, admission shall be done after the last date of admissions notified.
18. Admissions shall be made strictly as per provisions contained in Notification dated 08.08.2025. In case of any lapse/fault on part of institution or candidate, the University/Council will not be responsible for the same and no claim shall be entertained later on.
19. Any order of the Hon'ble Supreme Court/Punjab and Haryana High Court/other Courts/ amendments by the State Government/Government of India, Ministry of Health & Family Welfare shall be applicable.

ANY ADMISSION MADE BY ANY PRIVATE INSTITUTE IN THE STATE AT ITS OWN LEVEL OTHER THAN THE PROCEDURE PRESCRIBED SHALL NOT BE VALID AND SUCH ADMISSIONS SHALL BE CONSIDERED AS NULL AND VOID.
