- Application must be accompanied with attachment(s) containing your brief CV (with email id and mobile number clearly mentioned), age proof along with a recent passport size photograph affixed on application, qualification certificate(s), experience certificate(s), No objection certificate from current employer (if employed).
- Applications not accompanied by relevant documents will be summarily rejected.
- The candidates will initially be shortlisted based on the qualification(s) and their work experience. Only short-listed candidates will be called for an interview.
- The candidates must come with 2 passport size photographs, all original documents, and one set of photocopies of relevant documents, for interview.
- The work and conduct of all shall be evaluated per month.
- Physical interview of the screened candidates for post at sr. no. 1 will be tentatively held on 27.7.26 at 3.30 PM in **committee room, Director Office, Pt. B.D.S. PGIMS, Rohtak.**
- No TA/DA will be paid to attend the interview.
