The schedule for verification of the original documents
related to socio-economic criteria for the shortlisted
qualified candidates shall be notified on the University
Website. Based on the verification of the furnished
documents, the marks shall be awarded out of maximum
of 10 marks.
The candidates are advised to visit the University website
periodically in this regard.
In the event of failure to produce the original
document before the Scrutiny Committee on the
designated date, for which the benefit is intended to
be claimed, the candidate shall not be awarded any
marks for that particular criteria.
No request for submission of original documents at a
later date shall be entertained.
Final result of the qualified shortlisted candidates shall be
prepared, taking into account the marks obtained by them
in the Written Screening Test (Out of maximum 90
marks) and the marks obtained based on the socio
economic criteria (out of maximum of 10 marks).
