5. That if during the period of Clinical Assistantship, your performance/ conduct has been found to be unsatisfactory; your Clinical Assistantship can be cancelled at any moment.
6. That you will deposit amount of Rs. 50,000/- (Fifty thousand) (Non-Refundable) before joining, with the Fee Assistant of this office as fee to the condition that no remuneration shall be given to you.
7. That you will not ask/ claim complete partial refund of Rs. 50,000/- (Fifty Thousand) proportionate under any circumstances.
8. That you are not in the service under any Govt./Semi-Govt./Centre Govt./Private sector.
9. That you will not claim any hostel accommodation.
10. That you cannot be allowed to avail any kind of leave during this Programme.
