REMUNERATION:

Contractually engaged faculty members/doctors shall be paid consolidated monthly remuneration as under:

ENGAGEMENT PERIOD:

The engagement will be purely on contractual basis for an initial term of two years from the date of joining duty after acceptance of this contract. The term of engagement of the contractual employees may be extended by another two years from the date of joining or till the attainment of age of 70 years or till regular Incumbent joins (whichever is earlier). The period of contract can be reduced or extended at the sole discretion of the Competent Authority in Medical Education & Research Department, Haryana. However, the Govt. reserves the right to terminate the services of the faculty with one month prior notice without assigning any reason.

PROCEDURE OF SELECTION:

Interested candidates shall submit their applications in the prescribed format along with the self attested copy of required documents and passport size coloured photographs to the Director of the Institute through hard copy.

- The list of all eligible candidates from amongst the applicants against the published advertisement shall be published on website of the Institute along with the schedule for interview (subject wise).
- The applicants who do not fulfill the required qualification and experience will be rejected.
- If the information provided by the candidate is found to be incorrect, his/her application shall be rejected and disciplinary/legal action as deemed proper shall be initiated against him/her.
- Selection will be strictly on basis of Merit List prepared on the basis of teaching experience, research publications etc. 05 additional marks shall awarded to retired faculty members in the pre-merit.
- Eligibility for appearing before interview board is subject to documents verification on the day of interview.
- The applicant should regularly check the website of concerned Institute for any amendments and updates.

JOINING TIME:

A period of one month would be given to selected candidates for joining.

TERMS AND CONDITIONS:

- Engaged faculty under this policy shall, in addition to public holidays and restricted holidays, be entitled for ten casual leaves and ten medical leaves during a calendar year.
- Private practice of any kind including laboratory and consultant practice is not permissible. The faculty shall not engage himself/herself in any other paid assignment during the validity of the contract.

- Certificate regarding completion of the basic course in Biomedical Research from Institutions designated by NMC.
- The reservation policy both vertical and horizontal, applicable from time to time for direct recruitment, shall be followed. A roster shall be maintained by the Institute. It is clarified that in case of non-availability of suitable candidates of horizontal category, the suitable person of vertical category, if available may be considered eligible. In case of non-availability of suitable candidate of specific category, candidate of another category can be considered eligible. It is not a regular appointment; therefore, no backlog shall be maintained in case of non-availability of suitable candidates of reserved category.

Note:

1. Number of posts is liable to increase or decrease as the condition may demand.
2. No individual interview letter will be sent and no TA/DA will be paid for attending the interview. Candidates are advised to regularly check the website of the concerned Institute for latest updates.
3. Candidates must provide their e-mail ids and mobile no. as the interview dates and regular updates will be sent accordingly.
4. The cut off date for age/qualification shall be the date of publication of Advt. in newspaper/website.

The applicants who are already in Govt./Semi Govt./Corporation or Autonomous Body, should bring fresh, 'No Objection Certificate' at the time of interview, failing which the applicant will not be considered for interview, NOC may not be older than 03 months counted from closing date of inviting of applications.
