**Second round of Counseling for Admission to vacant/left over seats after 1<sup>st</sup> round Counseling held on 07.05.2017 in MD/MS/PG Diploma and MDS Courses in Government/Government aided/ Private unaided Medical/Dental Institutes including those under Private/Deemed Universities in the State of Haryana for the Academic Session 2017-18**

It is for the information of all eligible candidates that in view of order dated 09.05.2017 passed by Division Bench of Hon'ble High Court of Punjab and Haryana at Chandigarh in CWP No. 8649 of 2017, 'Dr. Narender Soni & others versus State of Haryana and others' having been stayed by the Hon'ble Supreme Court of India vide interim directions dated 16.05.2017 passed in SLP (C) Nos. 15171-15173 of 2017, 'State of Haryana and another etc, versus Dr. Narender Soni & others etc.' the second round of counseling for admission to MD/MS/PG Diploma and MDS Courses will be held as per the following schedule.

**22.05.2017 11:00AM for MD/MS and PG Diploma courses.**

**23.05.2017 11:00AM for MDS Courses**

The counseling shall be held in the office of Director PGIMS Rohtak.

All eligible NEET qualified candidates who have registered on the admission web portal upto 8<sup>th</sup> April, 2017 or those who have applied in Maharishi Markandeshwar University Mullana, Ambala upto 7:00PM on 08.05.2017 in compliance with the interim orders dated 04.05.2017, passed by the Hon'ble Supreme Court of India in Writ Petition Civil No.244 of 2017 titled, 'Education Promotion Society of India & Ors vs. Union of India & Ors' are advised to be physically present as per above mentioned schedule at the venue of counseling with all requisite original documents.

Final number of seats in each specialty under each category and in each Institute shall be displayed at the time of counseling. The candidates shall be allotted specialty and Institute based on their merit and option to be exercised by them at the time of physical counseling. However the candidates who have not registered on the admission web portal of Pt. B.D. Sharma University of Health Sciences, Rohtak ([www.uhspgadmissions.in](http://www.uhspgadmissions.in)) and have applied directly to Maharishi Markandeshwar University, Mullana, Ambala upto 7.00 P.M. on 08.05.2017 in compliance with the orders of Hon'ble Supreme Court dated 04.05.2017, shall be eligible for admission only in various specialities/branches of Medical/Dental Colleges under Maharishi Markandeshwar University Mullana, Ambala only. Candidates are advised to visit the website of Pandit Bhagwat Dayal Sharma University of Health Sciences, Rohtak [registrar.uhsrohtak@gmail.com](mailto:registrar.uhsrohtak@gmail.com) regularly for any update.

It is intimated that admission of all the candidates will be provisional and subject to the final outcome of decision in SLP(C) Nos 15171-15173 of 2017, 'State of Haryana and another etc, versus Dr. Narender Soni & others etc.' pending in the Hon'ble Supreme Court of India or any other writ/court case pending in Hon'ble Punjab and Haryana High Court or in Hon'ble Supreme Court of India or in any other High Court of any State.
