IMPORTANT NOTICE FOR AFFILIATED COLLEGES/APPLICANTS

It has come to the notice of the University that most of the affiliated colleges/applicants submit applications for Consent of Affiliation for new courses/additional courses/enhancement of seats/additional specialties with incomplete documentation and often after the prescribed due date as per the University Ordinance. This leads to unnecessary correspondence and litigation, causing delays and complications in the affiliation process.

As per **Clauses 04 (Note), 05 and 29** of the University Ordinance, the following must be strictly adhered to:

“For starting a new college/institution or for introducing a new subject/course or courses of study, it shall be incumbent upon the applicant/applicants to obtain, if applicable, a ‘No Objection Certificate’ (NOC) from the Government of Haryana, without which no request for affiliation shall be entertained.”

Further, as per **Clause 05**:

“On receipt of an application for recognition of a new college/institution, the Registrar shall, after ensuring that the application is complete in all respects, place the matter before the Vice-Chancellor, who will appoint an inspection committee consisting of three or more competent persons.”

In addition, **Clause 29** specifies that:

“All fees mentioned under this clause shall be non-refundable and non-adjustable from the Academic Session 2024-25.”

In light of the above, all affiliated colleges/applicants are hereby required to submit applications complete in all respects and to ensure the inclusion of the following mandatory documents:

1. No Objection Certificate (NOC) from the Government of Haryana for the respective course(s).
2. Forwarding letter from the concerned authority.
3. Prescribed fee (non-refundable and non-adjustable).
4. Duly filled application proforma in original.
5. All relevant annexures.
