Re-opening of Medical Colleges Post Lockdown due to COVID-19 Pandemic w.e.f. 07.12.2020.

In pursuance of Haryana Government Instruction received through E-mail vide memo no. DMER/Medical/A8/68/Spl-2 dated 03.12.2020 (copy enclosed). The medical colleges are to be re-opened w.e.f. 07.12.2020 after COVID-19 Pandemic Lock Down 2019.

1. The schedule of MBBS Practical classes / Clinical Training / Examinations in accordance with NMC guidelines dated 29-11-2020 is mentioned in table as below:-

03	3 rd Prof. part-I (Batch 2017)	21.12.2020 to 20.04.2021 (four months) including sent up examination	Last week of April / May, 2021
04	3 rd Prof. Part-II (Batch 2016)	07.12.2020 to 06.04.2021(four months) including sent up examination	Upto 3 rd week April, 2021

2. It is mandatory to all students to have Negative report of RTPCR (COVID-19) test before attending the Medical College as per NMC guidelines.
3. In this regards all the students may be directed to bring their RTPCR (COVID-19) test negative report which should not be prior to 72 Hours before attending the Medical College
