 - "Upgraded" in Round-3 seats and successfully deposited provisional tuition fee (if any).
 - "No Change" in Round-3 of seats (Hospital/College /Institution/course /category).
- The candidates with no change of seats in Round-3 should only bring the receipt of the documents submitted in concerned College/Hospital.

Candidates of all above groups should appear before the Admission Committee failing which provisional allotment will be cancelled.

Last date of reporting in the allotted institutes is 17.02.2025 (upto 05:00 PM).
