## PUBLIC NOTICE FOR ROUND - 3 SCHEDULE (MD/MS/DNB/DIPLOMA COURSES)

It is for the information of all the eligible candidates desirous of seeking admission to MD/MS courses in all Government/ Government Aided/ Private Unaided Medical Institutes including those under Private Universities - SGT University, Budhera, Gurugram, Al-Falah University, Village Dhoj, Faridabad and Post MBBS DNB/Post MBBS Diploma/Post Diploma DNB courses in Civil Hospitals/Medical College in the State of Haryana for the Academic Session 2024-25, the tentative schedule for Round-3 counseling is as under:

## Note:-

- 1. The candidates, who have already registered themselves for the Round-1 & Round-2 and wish to participate in the Round-3, shall not be required to register again.
- 2. The candidates, who have been allotted seats in the Round-1 / Round-2 of counseling shall have to give their willingness/option to upgrade themselves in the Round-3 of counseling status online otherwise they shall not be considered eligible for the Round-3 of counseling.
- 3. The Candidates, who have joined on the allotted seat in the Round-1/ Round-2 shall have a right to already allotted seat and this shall be changed only if, he/she gets an upgraded opted seat during Round-3. However, the candidates who wish to participate in the Round-3 of online counseling will have to submit their preferences/choices afresh. Candidates, who have been allotted, seat in Round-1/ Round-2 should give the fresh choices in order of preferences for the seats in which they wish to upgrade themselves.
- 4. All candidates (already registered (irrespective of their admission status) and freshly registered candidates) who wish to participate in the Round-3 of counseling and want to opt for State Quota Seats in only Government/Govt Aided/Private Medical Colleges shall be required to deposit online an amount of Rs. 25,000/- (Rs. 12500/- for SC/SCD/BCA/BCB/EWS/PWBD of Haryana State) and if the candidate wishes to also opt for State Quota Seats/Management Quota Seats in Private Medical Colleges including Private Universities then he/she shall have to deposit online an amount of Rs. 2.00 Lakh. This facility shall be available in the login ID of the candidates on admission webportal. In case of failure of any registered candidate to deposit the requisite security amount, they will NOT be considered eligible to participate in the Round-3 of counseling.

- In case of candidate join on the allotted seat, this security amount shall be adjusted in the tuition fee of the first year of PG Course.
- 6. If the candidates are allotted any seat as per their preference in Round-3, but they do not join on the allotted seat, the security amount shall be forfeited and these candidates will not be eligible to participate in the stray/ further round.
- 7. The security amount of the candidates who are not allotted any seat during the Round 2/Round-3 shall be returned after the completion of the counseling process.
- 8. The candidates, who join on the allotted seats in the Round-2 of counseling, will be eligible to participate for Round-3 of counseling.
- The candidates, who had deposited security amount in Round-2 but not allotted any seat shall not deposit security amount for Round-3.
- 10. Any candidate who had joined in Round-1 but do not participate in Round-2 counseling or do not resign from the Round-1 allotted seats, will also be allowed to participate in Round-3 after deposition of security amount.
- 11. The candidate who have been allotted/joined seat to them during the All India Quota/Any State upto Round-3 of counseling shall not be eligible in stray/ further round of counseling.
- 12. However, if a candidate do not want Round-2 seat, he may exit with forfeiture of security amount.
- 13. In case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled during document verification or fails to produce the required documents at the time of document verification, the security amount fee shall be forfeited.
- 14. As per Govt. of Haryana notification dated 02.09.2024, Clause 9(xv), "after exhaustion of merit list of the candidates who have applied under various reserved categories, vacant seats (if any) shall be reverted back to their original category(ies) of seats as per State Reservation Policy and filled up as per merit after conversion (For eg. BC-A seat to BC-B and finally to UR) and filled up in the 3rd round itself for both Government and Private Institutes. However, in case of any seat falling vacant after the 3rd round in any category, it shall first be offered to candidates belonging to original category of vacant seat of the previous round. In case, if the seat still remains vacant, the same shall be filled as per system in the 3rd round and so on".

## Note: -

- i. The choices filled by the candidates for the Round-1/Round-2 of counseling shall be treated as null and void and the candidates will have to fill fresh choices.
- ii. The above instructions should be read in accordance with NEET PG information bulletin 2024 and Govt. of Haryana notification dated 02.09.2024 & 20.09.2024 and public notices issued time to time.
- iii. Govt. of Haryana notification No. 40/13/2024-1SW dated 16.07.2024 is applicable for BC-A/BC-B category candidates.
- iv. Any modification in terms & condition will be applicable as per guidelines issued by MCC/Govt. of Haryana.
