CORRIGENDUM

Corrigendum to e-tender notice No. PGIMS/Cell-III/19/3402 dated 30.07.2019 reference tender No. 2019 & Tender ID. 2019_HRY_90579_1 due on 30.08.2019 up to 01:00 PM to be opened on 30.08.2019 at 03:00 P.M. Following changes are to be incorporated in the e- tender document, as per the decisions taken in the pre-bid meeting held on date 20.08.2019 at 03:00 PM.

1. *It was decided that the institute will provide infrastructure like space, electricity and water for the installations of autoclave etc. It was decided that w.r.t. point no. 14, 15 mentioned on page no. 04 and point no. 04 (a to c) at page no. 10 of tender document, it is clarified that the vendor shall install its own M&E and manpower for ensuring on site pre-treatment of Bio-Medical Waste. The vendors are advised to take a tour of different areas for assessing the exact requirement of M&E items and manpower. The vendor shall ensure that on site pre-treatment of Bio-Medical Waste shall be carried out as per provision of BMW(M&H) Rules-2016 or any amendment made by the statutory bodies from time to time. In case of any violation the vendor shall be solely responsible.*
2. *The tender document has already clarified that the Bio-Medical Waste is to be managed as per BMW(M&H) Rules-2016 or any amendment made by the statutory bodies from time to time. Therefore, the vendor is responsible for management of all categories of Bio-Medical Waste i.e. yellow, red, white and blue categories.*
3. *The validity of tender is already defined and there is no need to extend validity of tender as suggested by vendor. However, it was decided that in case the vendor is given extension beyond 02 years then the rates may be paid with 05% enhancement in the approved rates for second year.*
4. *It was decided that w.r.t point no. 03 at page no 03 & point no. 05 at page no.10 of tender document it is clarified that the vendor shall carry dry general waste to the dumping site identified by Municipal Corporation, Rohtak. The institute will request the Municipal Corporation, Rohtak for issuing authorization to the selected vendor for this work and the Government fee (if any) shall be paid by the institute.*
5. *It is clarified that condemnation is not a routine activity and is carried out only once/twice a year. Therefore, no additional payment will be made and the vendor shall dispose-off condemned material within the approved lum-sum rates.*
6. *The minimum office space will be provided at common collection site for record keeping and smooth working to the vendor.*
7. *The tender has already clarified that the selected vendor is responsible for ensuring all compliances given in BMW (M&H) Rules, 2016 and any amendment made by statutory bodies from time to time at its own level.*
8. *It was decided that w.r.t point no. (iii) under title Selection of Firm at page no. 05 the word rates/day/bed may be read as lum-sum rates.*
